EPIC BOD MEETING Minutes 7/17/2021 1-3 pm

Attendees: BOD: Cathy Egan (Presiding), Mary McKay, Christie McKay, Dana Deloca, Charles Spring, Penny Deloca, Karis Engle and Mary Stern Staff: Paul McKay and Tony Brun. Recorder: Linda Hardesty

1:05 Cathy opened the meeting, and called on Penny for a brief opening prayer.

1:07 Cathy called for corrections to the minutes from the 2020 AGM. Christie moved to approve, Dana seconded. All said "Aye"

1:10 Cathy called for approval of the 2020 BOD meeting. Charles moved. Mary seconded. The motion carried without objection.

1:15 Cathy called for feedback from the Board on the AGM just concluded this morning. Much appreciation was expressed. Videos and photos were great. Paul's niece email/texted her reaction as a first-time attendee and expressed approval of the quality of the information, visual aids and pacing. Things that need to improve include making sure the zoom link goes out. Karis and her husband Owen did not get theirs.

Mary mentioned that Tony has arranged for all the Program Directors to meet on Zoom once a month for the last year, with great cross-leavening and mutual aid coming about from it.

1:25 Cathy suggests we reach out for new officers for next year, including President, Vice President, and Chair person. Mary mentioned that Linda Hardesty and Chris Stauffer are officers but not board members. Their work is very important and helpful. Cathy presented the current slate of proposed officers as: Dana Deloca, President, Christie McKay, Vice President, Linda Hardesty, Secretary, Chris Stauffer, Treasurer and Cathy Egan, Chair

Charles moved the officers be elected. Mary Stern seconded. All approved.

1:30 Paul's "State of the Union" for EPIC (See attached)

Paul read us three sweet "Thank you" notes he received along with donations. These demonstrate the satisfaction that many of our donors receive from supporting EPIC.

In addition to the 2 PPP loans EPIC received (and were forgiven), we have applied for a "ARC" federal tax grant that the government made available to encourage organizations to keep employees. This pays only for employees, not for contracted services. We are waiting to hear if EPIC will receive this federal grant.

1:45 Mary presented a one-page financial overview, See attached "EPIC's Fiscal Year 2020 - 2021"

Mary also presented the "Statement of Financial Position". (Attached) She remarked that Paul had worked to get all of our financial assets into socially and ecologically responsible investments. No questions were asked, but Cathy expressed appreciation for the conscientious hard work that went into these reports.

1:48 Mary presented an analysis of our donors. EPIC does not have wealthy donors and even our larger donors are "ordinary" people. Fortunately, we have many small donors. It is important to keep these donors engaged. Paul and Mary elaborated as to who had brought in new donors this year as an example of how important this is for EPIC's fundraising.

2:10 Paul discussed the work of Scott Brink as a "prospector" for foundations that are offering grants. Scott is looking through lists to find matching or promising funders. It is complicated to find funders, because foundations often have very specific requirements for projects. Our program staff already have well designed programs adapted to their locations We can't go making big modifications to their plans that wouldn't work for their programs just to qualify for foundation grants. Scott's work is to find funders that match the work we are already doing or want to do.

2:15 Mary talked about in-kind donations of time and materials and how that must be reported to the IRS.In total these had a value of \$101,040 this fiscal year, with 52 individuals donating. Since EPIC has received a large amount of material aid (especially vegetable seeds, masks for Covid protection, and trees for reforestation), Chris Stauffer will need to report this on a special IRS form. (See attached "2020-21 In-Kind Gifts and Volunteer Labor")

2:23 Cathy put out some questions for discussion tomorrow. Should we have an in-person AGM next year (summer 2022)? We should make the decision tomorrow? Paul says it would be a big loss if our project partners were not included next year in the way they have been in this year's zoomed AGM meeting. Cathy suggests a hybrid system (like we have seen at Boulder Mennonite Church) where some meet in person and others are included online. If we are continuing with an online-only meetings, might we separate the AGM from the BOD meetings time-wise to spread out the work? Cathy doesn't like the meetings to be in summer in general, so if we make them online only, might we change to another time of year?

2:32 Cathy tentatively proposed dates for BOD teleconferences during this next year to be considered tomorrow.

2:34 Cathy asked Mary to reflect on the pros and cons of expanding the size of the BOD. Mary observes that a small BOD is easier to coordinate. However, many of our peer organizations have 11-member boards. If we expanded the BOD from 9 to 11 we could have more energy and spread the work around among our members, who have busy professional lives apart from their EPIC duties. Cathy observes that we could also set up special committees to do volunteer work rather than trying to find more folks willing and able to commit to a 3-year BOD term.

2:44 Mary asks all members to read through the materials sent out on Wednesday concerning the hiring of a new Development Coordinator before the discussion tomorrow.

2:53 The meeting was adjourned until 8 am MT tomorrow.

Financial

We'll be talking about this more during the meeting, but we "Made Budget" In FY 2018-19 EPIC had a deficit of \$173,526 That year we had 184 donors

This year income was more than \$19,000 over expenses.

The number of donors increased to 312

407 donations were entered by Vision Bookkeepers and then acknowledged personally To give a human face to some of our donors I will read 3 "Thank You" notes that accompanied donations: Viva; David; & Bruce

This is a huge turnaround from 2 years ago when expenses were way more than income.

Applied for, received, and then received loan forgiveness for 2 PPP loans, and have applied for one more Covid related government grant, \$8,395.38 which is a credit toward payroll taxes. To qualify we EPIC must hold the course having employees rather than contracted services.

B. Now have a new Printing Company who gives EPIC a 10% discount.
The great printers we had used since we moved to CO retired and sold the business. EPIC now has new letterhead and BRE's (Barry had none printed.)
C. Little Green Light is now our donor relations CRM Customer Relations Management system

A. Were able to rework their program activities to adapt to the restrictions and precautions necessary with Covid

- B. Took on responding to 2 Hurricanes while still in the middle of a pandemic
- C. Several programs partners have young, energetic and well educated leadership who want to do more and more. (We'll talk about this later in the BOD)
